Customer Declaration

Carcierge Limited ("Carcierge") offers the Vehicle for hire subject to the following conditions:

1. The Vehicle is insured on a fully comprehensive basis by Carcierge at all times, whilst in my custody. This carries an excess of £2,000 for which I accept liability, although I understand this will be refunded if it is recovered from a third party. The policy does not cover personal effects, which remain at my own risk.

- 2.** I accept liability for any uninsured damage caused to the Vehicle, during the hire period, due to driver error, carelessness or negligence, including but not limited to: clutch; gearbox; engine; tyres and alloy wheels.

- 3.** I am over 25 and under 70 years of age. I do not suffer from any physical or mental impairment affecting my ability to drive the Vehicle, such as: loss or loss of use of limb or eye; defective hearing or vision (not corrected by spectacles or hearing aid); a heart/diabetic/epileptic condition; or from any other infirmity that should be disclosed to the DVLA.

- 4.** I have held a valid UK or EU driving licence applicable to the Vehicle for at least 3 years and have a minimum of 3 years recent driving experience in the UK.

- 5.** I have not accumulated more than 6 penalty points for speeding in the last 3 years, nor have I been disqualified from driving in the last 5 years or have any outstanding motoring convictions other than parking or speeding related endorsements.

- 6.** I have not been involved in more than one accident, whilst driving, during the past 3 years.

- 7.** I have not had insurance declined and/or renewal refused and/or special insurance terms imposed upon me as a result of my claims experience, nor have I had insurance or cover cancelled by any Motor Insurer.

- 10.** I am not engaged wholly or partly in professional entertainment or professional sports, nor am I a Jockey or connected with racing of any sort.

- 11.** I accept that any motoring or traffic offences, toll charges, penalties and fines arising in relation to the vehicle from the time the Vehicle is provided to me until the time it is returned, are my sole responsibility under the Road Traffic Offenders Act 1991 and the Road Traffic Regulation Act 1984. I will indemnify Carcierge forthwith for any penalties, fines, legal fees, costs, interest or other charges paid by them in relation to any such motoring or traffic offences or toll charges. I hereby irrevocably consent to any such charges including an administration fee of £50 being charged to me.

- 12.** I accept a charge of £1.00 per mile driven, during the hire period.

- 13.** I will replace all fuel (RON 97 or better) used during the hire period, or be charged for it at a cost of £1.00 per mile driven. I will pay any charges for loss/damage as a result of not using the correct fuel (this is a PETROL vehicle).

- 14.** I understand the Vehicle is only insured to be driven by the person(s) named above who have signed this form. I will indemnify Carcierge in full against any and all claims, costs and expenses arising out of the driving of the Vehicle by any other persons.

- 15.** I will not enter into any other agreement with any third party to further hire or loan the Vehicle.
- 16.** I will only use the Vehicle for social, domestic and pleasure purposes and agree it will not be used for business purposes, including use for hire and reward, taxi or courier business purposes.
- 17.** I will not use the Vehicle for driving tuition, racing, pace making, rallying, competitive hill climbing, speed-testing, off-road trials or any other such sporting competition, or for any illegal purpose.
- 18.** I will not use the Vehicle on a track or for off road purposes or in any way that contravenes the Highway Code or relevant road traffic laws.
- 19.** I understand the Vehicle's controls; agree not to disengage any of the passive safety features and to leave it secured at all times with the keys removed. I understand failure to do so will invalidate the insurance policy and in the event of a loss I shall become liable for the full value of the Vehicle.
- 20.** I will allow the Vehicle's engine to get up to its optimal operating temperature before using more than 4,000rpm. I understand that this is achieved through normal driving (not idling) for a minimum of 15 minutes. I understand that failure to follow this procedure can damage the engine, for which I accept liability.
- 21.** I will not take or use the Vehicle outside the UK and recognise that failure to observe this term will be considered theft and the police will be informed.
- 22.** If the Vehicle is in my custody overnight, I will park it in a secure location, off the public highway and I will store the Vehicle's key in a safe place (e.g. the bedroom).
- 23.** I will return the Vehicle at the end of the agreed hire period, or whenever requested, and agree to pay £300 per day if the Vehicle is not returned within 2 hours of the agreed time, plus a storage charge of £25 per day for any vehicle left at Carcierge's premises.
- 24.** I will not smoke or allow animals in the Vehicle and I will return the Vehicle in a clean and serviceable condition, and agree to pay £150 for cleaning if required.
- 25.** I agree that if I am in breach of any significant policy conditions then Carcierge has a right of recovery against me.
- 26.** I agree to the terms and conditions on all pages of this agreement.

27. I further agree to be bound by the terms and conditions of the Insurance which I have seen and read or have had the opportunity to see and read.

28. I agree to have my photograph taken alongside the Vehicle immediately prior to commencing the hire.
